

# **Select Engagements**

- Won a six million dollar judgment in favor of a client in the gaming industry based on a breach of contract by the client's former partner.
- Represented several Energy Service Companies ("ESCOs") in class action lawsuits and investigations by state attorneys general and other government agencies.
