Christopher Petersen is a litigation partner in Blank Rome’s Los Angeles office. ## **Select Engagements**

- Successfully litigated several issues of first impression under the Charter

Schools Act on behalf of many of the largest non-classroom-based charter schools in California, including issues impacting the locations at which these schools are permitted to operate. This also includes litigation defending the schools from claims by several public school districts regarding the interpretation and application of California Education Code § 47605.1(d), commonly referred to as the “unable to locate exception,” and California Education Code § 47605.1(f), commonly referred to as the “Workforce Innovation and Opportunity Act (WIOA) exception.”

- Represented three co-trustees of a family trust against claims by the fourth co-trustee for breach of fiduciary duty and misappropriation of trust assets. The focus of the action was whether the three co-trustees had properly used trust assets to care for the parties’ mentally and physically disabled adult brother (which was the intent of the settlors). Chris was part of the Blank Rome team that helped the three co-trustees present a precise and concise accounting and explanation of how the trust assets were used for the benefit of the disabled brother, and to defeat the claims of the fourth co-trustee that religious law trumped secular law to govern the distribution of trust assets.
- Successfully defended trustees of family trust with assets in excess of \$10 million as trial counsel in action seeking to surcharge and remove trustees based on alleged breaches of fiduciary duty and mismanagement of trust assets.
- Obtained judgment of foreclosure and order of sale in excess of \$10 million as trial counsel in breach of contract and judicial foreclosure action.
- Obtained multimillion dollar judgment against one of California’s largest property developers as trial counsel for a limited partner alleging claims for breach of contract, breach of fiduciary duty and fraud.
