Greg is the recipient of numerous honors and awards, including the Attorney General's Distinguished Service Award, the United States Coast Guard's Distinguished Public Service Award, three Special Commendation Awards from the Department of Justice, and the Bronze Medal from the Environmental Protection Agency.

Greg is a frequent author and speaker on environmental criminal and compliance issues.
