Harrison's areas of experience include successfully defending class actions involving telemarketing under the federal Telephone Consumer Protection Act ("TCPA") and Florida's Telephone Solicitation Act ("FTSA"), the Federal Trade Commission Act and California's Unfair Competition Law ("UCL") and Consumer Legal Remedies Act ("CLRA"), Illinois' Biometric Information Privacy Act ("BIPA"), California's Song-Beverly Credit Card Act, chatbot and wiretapping litigation under California's Invasion of Privacy Act ("CIPA"), and California's Automatic Renewal Law ("ARL"). Harrison has secured early dismissal of multiple class action lawsuits prior to class certification, protecting sensitive customer lists from premature disclosure.
