- Successfully obtained a mandatory injunction enjoining defendants from improperly passing-off inferior and dangerous counterfeit Chinese building materials manufactured below industry standards (containing a known carcinogen).
- Successfully obtained a summary judgment on behalf of a public utility after a gas explosion occurred in a residential neighborhood, resulting in claims brought by six different plaintiffs for, among other things, wrongful death, permanent disabilities, and property damage.
