In 2018, she was recognized by Blank Rome with its Pro Bono Hero award for her work representing a juvenile who had been unconstitutionally sentenced to life without parole. She has also been named to the First Judicial District of Pennsylvania's Pro Bono Roll of Honor.

Melissa is also a member of Blank Rome's Recruiting and Retention Committee and the firm's Well-Being Committee. She previously served on the firm's Associates Committee.
