

She has represented clients in a number of industries, including automotive, energy, and manufacturing.

Stephanie interned with the Honorable Jacob P. Hart, U.S. Magistrate Judge for the Eastern District of Pennsylvania and the Environmental, Health, and Safety legal department at Tyco International. At law school, she took first place in the 2005 I.
